**THE BEGINNING**

**It all started after 2008, the family of the Dobrev Dynasty Halachev refused to a criminal statesman designated as such by states, the USA, and other countries, at a high state level refused to give assets to the family at a price 90,000 times below the market price.**

**Death threats followed for Momchil Dobrev's father - Dobri Duchevev managed three different industries during the socialist era and hundreds of enterprises in the field of mechanical engineering, the chemical industry, forklifts and transport machinery and made hundreds of millions of US dollars in the development of these industries, for which the**



socialist authorities headed by the state prime minister and first secretary of the Bulgarian Communist Party have many times wanted to **THROW HIM IN PRISON BECAUSE HE RULED PROFITS LIKE A CAPITALIST.**

After the threats of extortion and coercion in September 2008, Dobri Dobrev Dobrev suffered a stroke and broke his hip in the hospital in the city of Burgas. He was immediately transferred to a hospital in Sofia by his son and underwent emergency surgery.

2010, by order of the Prime Minister **BOYKO BORISOV** and with the participation of a private bailiff Georgi Saykov Dichev, persons close to the mafia Krasimir Vollov, other CHIs such as Ivan Cholakov and Nedyalka Kovacheva, and prosecutors Sotir Tsatsarov, Mariyana Stankova, Boyan Balev, tax audits were initiated by the National Revenue Agency, which sought only from Momchil Dobrev "unpaid taxes" as an individual 48 million leva, which is equivalent to the fact that he as an individual made over 4.8 billion leva - that much dollar turnover per year. The order of the then Prime Minister Boyko Borisov is carried out by the prosecutor's office, tax, and all services. This has been confirmed by various persons and most notably by General **LYUBEN GOTSEV** - the general of the mafia in Bulgaria.

After **THREE YEARS OF RACKET AND FORCEMENT** The National Agency for Privods comes out with audit reports that **MOMCHIL DOBREV, DOBRI DUCHEV DOBREV** do not owe a penny.

Because of this racketeering and extortion, Momchil Dobrev is suffering from diseases, diabetes and other illnesses.

The murder attempts began in 2011 - setting fire to the apartment where Momchil Dobrev's parents live, while his father is in bed. They almost burn like **TORCHES**.

This was followed by January 2012 when a **BUS** was waiting for Momchil Dobrev at his office to crush him, and after Momchil's quick reactions, the bus just passed by and crushed one of his legs.

September 2012 at a trolley stop located in front of the Stock Exchange Commission, the entrance to which has three cameras, a person from the criminal contingent inflicted 17 blows with an umbrella handle on the left side of the face of Momchil Dobrev, who, with two full hands with two bags with two laptops, could not stand up.

**NO ONE INVESTIGATES THE MURDER ATTEMPTS** of Momchil Dobrev and until now 2025..

Since 2006 Momchil Dobrev informed the European Commission and the European Union about the **MAFIA** in the **STATE AT THE STATE LEVEL** with Minister President **SERGEY STANISHEV**, **BOYKO BORISOV** and Ministers of Justice Prof. Bliznashki, **MARIN RAIKOV**, and others about crimes, about the mafiaization of the court and the prosecutor's office which legalize the theft of properties, factories, for billions of euros of the Dobrev Halachev family.

After dozens more attempts to murder **MOMCIL DOBREV**.

September 2019 35 days Momchil Dobrev protested with posters in front of the courthouse in the center of Sofia with posters with evidence of the mafia in the court, with cited evidence of crimes of judges **VALKOV, ALBENA BOTEVA, RAINA MARTINOAV, ALEKESY TRIFONOV, ALEXANDER ANGELOV, LYUBKA GOLAKOVA**, , Daniela **DONCHEVA**, Svetlin **MIHAYOLEV** Gerogi **KOLEV**, the President of the Supreme Court of Cassation **LAZAN PANOV**, Deputy President **KRASIMIR VLAHOV**.

The posters with evidence listed crimes of prosecutors of the Prosecutor General Ilchev Doc Velchev, of **SOTIR TSATSAROV** which prosecutors legalize crimes, thefts of private property worth billions of euros, factories worth hundreds of millions of euros, crimes committed by prosecutors stretched over criminals - judges, people of the mafia.

After this protest on behalf of the general, the boss of the mafia in BULGARIA, General LYUBEN GOTSEV and on his words said to Momchil Dzobrev three months before he died in 2020 on his behalf LYUBEN GOTSEV, BOYKO BORISOV, the Prosecutor General SOTIR TSATSAROR, with the participation of the judges, the chairman of the Sofia City Court ALEXEY TRIFONOV with two civil - Bulgarian and Russian, the judge RAINA MARTYNOVA, who falsified the court record and with 17 forgeries, is the 10th attempt to murder MOMCIL DOBREV on 19.02.2020, and this case will be described in another article.

In parallel, in 2015-2016, close to the Prime Minister BOYKO BORISOV and DELIAN PEEVSKI, the companies HYDROSTOY and VODSTORY 98 stole 2.9 million cubic meters of private land from the demes of the Dobrev Halachev dynasty and used them for the construction of the northern tangent of the capital Sofia. According to General GOTSEV BOYKO BORISOV and other individuals, the latter received a bribe of 50 million for this theft.

2023 Lord Academician Prof. MOMCHIL DOBREV in March 2023 filed a lawsuit in the New York District Court under the RICO ACT against the Prime Minister BOYKO BORISOV, the Prosecutor General SOTIR TSATSARO, prosecutors, judges, and mafia companies involved in the theft of land for 130 million euros.

**AS A RESULT, THE FOLLOWING WAS ANOTHER ATTEMPT TO MURDER MOMCHIL DOBREV on November 1, 2023 in the building of the Sofia District Court.**

**SINCE 2001, Momchil Dobrev formed a non-profit association "Association for Morality and Honor for Bulgaria" to fight corruption and mafia in the court, prosecutor's office, state.**

**2020 Lord Acad. Prof. Momchil Dobrev and Lady Prof. Mariola Garibova-Dobrev publish another book to fight the MAFIA "RESTART OF BULGARIA - WITHOUT MAFIAISM in COURT, PROSECUTOR'S OFFICE, STATE. Theory of mafiaism by Prof. Momchil Dobrev " with hundreds of evidence of crimes by judges, prosecutors, statesmen, ministers, theft of hereditary properties for over 5 billion US dollars, by oligarch EMIR KYULEV owned by the Dobrev Halachev Dynasty, with false acts of municipal property issued by the mayors of Sofia SOFIANSKII, BOYKO BORISOV and FANDAKOVA, and the inaction of the current mayor of Sofia - TERZIEV --. Who does not want to fulfill the COURT DECISION THAT HAS ENTERED INTO FORCE and hand over the properties owned by the members of Dastia Dobrev Halachev – properties worth hundreds of millions of euros.**

*As early as September 2008, pressure began on the father by phone from 11 pm to 3 am, with DD being invited to donate the properties to the then Prime Minister BB and threats. Since September 2008, after an operation in a hospital in Sofia, DD has been bedridden in the city of Sofia.*



*After threats and extortion against the D. family did not work out. Former colonels from the State Security, posing as representatives of the Prime Minister BB, began to want to buy the properties at a price 9000 / nine thousand / times below the market price.*

*After the refusal of this proposal, actions were taken in various institutions.*

*Following letters from the Chairman of the Chamber of Private Enforcement Agents Georgi Saykov Dichev, to the National Revenue Agency, to the Prosecutor's Office, to the Sofia City Prosecutor's Office, decrees were issued by Prosecutor Mariyana Stankova from the Sofia City Prosecutor's Office to appoint tax audits.*

*After colonels from the State Security in 2010 and 2011 with an office on Vitosha Blvd. - a former police station - offered the family D. and presented themselves under the NAME of BOYKO BORISOV and offered to buy these lands owned by the family D. at a price 9000 / nine thousand / times below the market value?!?!,*

*And after the members of the family D. refused to sell their lands, the National Revenue Agency and the prosecutor's office got involved, tax audits began, prosecutor Mariyana Stankova issued decrees for tax audits, followed by foreclosures of all properties of the D. family, as well as the disputed lands of 2,050 acres and 2,170 acres.*

*The National Revenue Agency is seeking unpaid taxes from the son of the MD family for 2,000,000 / two million / leva, 6,000,000 / six million / leva, 8,000,000 / eight million leva,*

*Taxes in the amount of 2,000,000 are being sought from the father D, and 2,000,000 / two million / leva from the mother,*

*Following a complaint from a person claiming to have the support of the GERB party and the DPS party, Krasimir Mollov, a prosecutor's file was opened. There are also letters from the chairman of the Chamber of Private Enforcement Agents GEORGI SAYKOV DICHEV to the prosecutor's office, the National Revenue Agency, and the Sofia City Prosecutor's Office.*

*2011 an arson attack was committed on the apartment of the D family, 2012 at the beginning of the year a bus was waiting for MD at his office to hit and crush him, but it only passed through his leg.*

**The quoted words are ALREADY RECORDED from the 6th minute to the 7.56th minute.**

**I.e. THERE IS STILL A DISCREPANCY HERE.**

**AFTER LISTENING TO THE RECORDING, IT WAS ESTABLISHED THAT THE WORDS WERE NOT SAID ANYWHERE: THE THREATS - "I WILL CUT OFF YOUR HEAD"**

**I.e. what was written in the minutes of the meeting of 21.11.2019, which the secretary stated was prepared by judge RAINA MARTYNOVA, does not correspond to the truth and is a lie.. WRONGLY WRITTEN - WRONGLY reflected - WRONGLY CONTENT.**

**The secretary stated that she did not prepare the minutes and was then forced to sign it, because judge RAINA MARTYNOVA prepared it - IN VIOLATION OF THE LAW.**

**That is, there was a preparation of a document with false content.**

In addition, it is evident from an order dated 28.10.2019. Judge RAINA MARTYNOVA in the civil case, SHE orders a recording of the court session to be made, AND THERE WAS NO SUCH A RECORD, on a disk. That is, on 28.10.2019. A RECORD WAS MADE NOT FROM THE CIVIL CASE SESSION, but from the court session on 22.11.2019. but FROM ANOTHER CASE. M-th in the corridor in violation of all laws were two ARRESTS WITH SCREWDRIVERS IN THEIR HANDS, and THEY SHOWED ME. After I told the two police officers that these screwdrivers would stop in THEIR BODIES, THEY FELT LIKE DISAPPEARING AND HIDE. AND DESPITE THIS HER OBLIGATION – of RAINA MARTINOVA TO OBEY THE LAW the same instead of being taken to case 3726/2010 of the Sofia City Court the same on date 22.11.2019. HELD A COURT HEARING on this case, the case lasting one hour. On 09.12.2019. A protocol from the court hearing of the case from 22.11.2019 appears. in which it is explicitly written that I made THREATS to the judge at the 2nd minute of the court session, WHICH REALLY DOES NOT CORRESPOND TO THE TRUTH, since neither Judge RAINA MARTINOVA HEARD these threats, which were made by me to the defendant - my sister, and the court session continued PEACEFULLY AND QUIETLY FOR AN HOUR, WHILE THE WHOLE TIME JUDGE RAINA MARTINOVA WAS CHEATING ON ME in the**



**COURT HALL, which she was repeatedly asked not to do, after all, she is a judge and should not do this to me. In violation of the LAW, THE MINUTES OF THE COURT HEARING in the civil case on 22.11.2019 were prepared in violation by JUDGE RAINA MARTYNOVA, not by the secretary. THIS IS ANOTHER EVIDENCE OF A PREPARED TRAP. IN ADDITION, THE CLEAR SUPPORT OF THE PRESIDENT OF THE SCC ALEXEY TRIFONOV IN THESE VIOLATIONS OF THE LAW BY JUDGE RAINA MARTYNOVA PROVES COMPLAINT. Then REALLY on 19.02.2020. I was DETENTIONED ON HER COMPLAINT and AN ATTEMPT WAS MADE TO KILL ME IN THE ARREST OF WHICH I WAS NOTIFIED IN SEPTEMBER AND OCTOBER 2019. THAT THE COURT OF THE SCC WILL ORGANIZE SUCH A TRIAL THAT I WILL BE DETENTIONED AND AN ATTEMPT WILL BE MADE TO MURDER ME, WHICH DID NOT HAPPEN. That is, there are unlawful actions BOTH on the part of judge RAINA MARTYNOVA who had not yet received a DISMISSAL IN ALL MY CASES on 07.11.2019 AND ON THE PRESIDENT OF THE SCC OF THE SCC ALEXEY TRIFONOV, who knew about the complaint of 07.11.2019. AND STILL THIS DID NOT DIRECT JUDGE RAINA MARTYNOVA TO COMPLY WITH THE LAW and to be taken away.**

TO BE TAKEN AWAY, and judge ALEXEY TRIFONOV to direct her to OBEY THE LAW, which he did NOT DO CONSCIOUSLY – EXACTLY THE OPPOSITE.**

The takeover of a country or union is carried out by people who rule the mafia and the oligarchy, the deep mafia, the deep state, people who own companies, corporations, members of Masonic lodges, commissions like .....

The plans for taking over a country go through different options:

- Through war
- Through conquest - military, with invasion, attack, aggression,
- Through counter-revolution - color counter-revolution - coup d'état and external rule, carried out by artificially creating political and economic instability, destruction and blackmail of society with open terror.

Control is achieved by appointing judges, prosecutors, investigators close to the mafia as heads of courts, prosecutors - the prosecutor general and the heads of district prosecutors' offices, city and district prosecutors' offices.

Control of the judicial body - the Supreme Judicial Council

Control of the inspector to the judicial body - the inspectorate to the Supreme Judicial Council

Control of the Constitutional Court - appointment of constitutional judges close to the party oligarchy who carried out orders of the mafia

Control of the courts through the chairman of the Supreme Court of Cassation, the Courts of Appeal in Sofia, Plovdiv, Veliko Tarnovo, Varna and Burgas, control of the largest district court - Sofia City Court by appointing judges who are loyal and close to the mafia. Appointment of court presidents close to the mafia and the oligarchy, who will unquestioningly carry out the orders of the mafia - to terminate cases, to lose cases against the mafia.

Mastering the system for appointing judges - ignoring, bypassing the electronic system for random selection, as deputy presidents and deputy presidents of courts appoint a specific judge for a specific case, who will carry out the respective order of the mafia and the oligarchy.

Mastering the system for appointing judges in cases in the Supreme Court of Cassation - by appointing close chairmen of the Supreme Court of Cassation to people close to the mafia and respectively deputy chairmen of separate courts - civil, commercial, criminal, to appoint precisely defined judges for precisely defined cases, who will carry out the mafia's order,

Mastering the system for appointing judges in cases in the Supreme Administrative Court by appointing close chairmen of the Supreme Administrative Court to people close to the mafia and respectively deputy chairmen of separate courts - civil, commercial, criminal, to appoint precisely defined judges for precisely defined cases, who will carry out the mafia's order.

Creation of administrative courts to protect and legalize crimes committed by ministers, officials of state agencies, state services, ministries, against citizens, companies.

Creation of administrative courts to legalize repression, harassment, coercion carried out by the mafia through state institutions such as the National Revenue Agency, to convict honest citizens who do not succumb to the mafia.

Appointment of mafia people as court presidents through which courts will:

- Legalize the theft of private property by the mafia and the oligarchy

## **17. CONCLUSION**
